- **Termination Qualifications** Termination of membership in the Plan occurs immediately after termination of Union membership. You may also elect to terminate membership in the Plan after you have left the Sprinkler industry for two or more years and you do not satisfy any of the conditions of normal or early retirement. Leaving the Sprinkler industry means that no contributions are being paid by you or on your behalf to this Plan.
- **Election Statement** You will receive an Election of Benefit on Termination of Membership from the Plan's administrator which will provide you with the actual amount of any pension that you may be entitled to under the Plan as well as outline all of the options available to you including the opportunity to transfer out your entitlement.
- **Designation of your Beneficiary -** Note that after your death any pre-retirement death benefit payment would normally be first payable to your Spouse as required by law. You may designate any person or your Estate as your beneficiary and that person would receive any death benefit that is not required to be paid to your Spouse. If your Spouse has died before you, your designated Beneficiary would receive any death benefit payment. The Beneficiary that you designate on this Application only applies or comes into effect after your death if you do not have a Spouse. If you do not designate a Beneficiary and you do not have a Spouse, any death benefit would be paid to your Estate.
- **Definition of Spouse -** To qualify for any spousal benefits under the Plan, your Spouse must meet the requirements there for in accordance with the laws of the province of your residence. In general, this would be a person who
 - (a) is married to you and is living with you on the date of your retirement, or
 - (b) if there is no such person, is that person whom you are cohabiting with as a spouse on the date of your retirement and with whom you have been cohabiting continuously with as your spouse prior to your date of retirement for a minimum period of three tears (two years for residents of British Columbia and New Brunswick). If you live in Manitoba, Nova Scotia or Newfoundland, the minimum period is one year if neither of you are married to someone else or three years if one of you is married to someone else.
